Item #1 on the Agenda – Call to Order – Pledge of Allegiance

Item #3 on the Agenda – LA Alliance for a New Economy (LAANE) "Raise the Wage Presentation"

Imelda Padilla - LA Alliance for a New Economy (LAANE) - an update was given on Raise the Wage Campaign. Ms. Morin sponsored an agenda item to present this to the Board for a Community Impact Statement next month.
