Work with 3000 low-income youths and families

Their Organization is a 2.8 million dollar organization – 85% is government grants (city, county, state, federal funding).

Services provided: counseling, therapy and mental health services to youth and families. They are located on Lankershim Blvd, North of Sherman Way

Youth employment and training to work in different areas throughout the community (administrative, community cleanup work, etc.) are provided.

Their Environmental Services Department remove graffiti throughout the valley and provide cleanups, and bulky item pickups.

Provide Living and life skills education for youth in the foster care system and probation system.

Provide gang prevention and working with juvenile offender. Provide reentry services for youth who

	are coming out of detention in juvenile halls: academic support, GED preparation, counseling resolution and anger management and recreation to participate in wellness activities. Provide parent education and training with certified parenting instructors, five parenting classes per week. Four in Spanish and one in English. Provide music, arts and health. They built a music recording studio on their site. Also, a dance studio and a fitness center to promote wellness in young people. Provide Showers, washers and dryers for homeless youth.
