

North Hollywood North East Neighborhood Council COMMUNITY IMPACT STATEMENT AGAINST COUNCIL FILE 23-0662

Oversized Vehicles / RV / Homelessness / Overnight Parking Restrictions / Safe Parking /
Enforcement / Citations / Tows

December 13, 2023

On August 8, 2023 the City Council approved a motion referred from the Transportation Committee (CF 23-0662). The North Hollywood North East Neighborhood Council (NHNENC) is against the motion.

The NHNENC respectfully requests that LAMC 80.69.4 continues and that it be enforced.

As this motion was focused on data gathering, we would like to share the lived experience of some of our stakeholders that live near the Oversized Vehicle Restricted Area (OVRA) in North Hollywood in Council District 2 on Saticoy St between Laurel Canyon Blvd and Whitsett Ave. (Photos Attached from November 2023) There are currently four (4) RV Dwellings along with several other smaller vehicle dwellings that are located on the north side of Saticoy Street between Shadyglade Ave & Laurel Canyon Blvd. There is signage that parking is prohibited between 2am to 6am for vehicles over 7' high or 22' long (LAMC 80.69.4). Additionally, there is signage that there is street sweeping between 10am- 12 noon on Wednesdays and there is no parking allowed at that time. Yet, there has been no enforcement. Two of these RVs have been there for over a year and the others for many months. And though unrelated to the OVRA, there is also electricity theft from one of the public light poles. There are yellow extension cords that are connected to the public light pole and are running along the sidewalk to bring power to three

of the four RVs. The fourth RV had an exposed generator on the sidewalk. Both of these are safety issues.

As noted in the motion, there are several actions that the City Council has approved to address the homelessness and RV/Vehicle dwelling crisis. CF 22-1313 and CF 22-1324 are two such examples. We believe that this effort to gather data and facts is technically appropriate and can possibly help assist the other actions being made to assist those who live in RV Dwellings to find 24/7 Safe Parking and eventually stable housing, but are concerned with the possible action the committee will take. As you review the requested reports, we ask that you also consider the impact on all stakeholders in your decisions regarding LAMC 80.69.4 / OVRA and leave it as is.
