I am seeking to serve as a Board Member for the following Seat(s):

- Resident Stakeholder Council Members – Includes residential property owners and renters who reside in this Council area. Open to Stakeholders eighteen (18) years of age or older who provide satisfactory proof of owning or renting a residence which is located within the NC boundaries.
Business Stakeholder Council Members – Open to Stakeholders eighteen (18) years of age or older who provide satisfactory proof of working or owning a business or business property within the NC boundaries.
Community Organization Stakeholder Council Members – Open to Stakeholders eighteen (18) years of age or older who participate in a community based organization, including but not limited to a religious institution, educational institution, non-profit organization, neighborhood association, school/parent group, faith based group, senior group, youth group, arts association, service organization, boys or girls club, cultural group, or environmental group within the NC boundaries
At-Large Stakeholder Council Members – Open to Stakeholders who are 18 years of age or older at the time of the election and who provide satisfactory proof that he/she lives, works or owns property within the NC boundaries.
Community Interest Stakeholder Council Member - Open to Stakeholders who are 18 years of age at the time of the election and who provide satisfactory proof that he/she lives, works, owns property or claims an ongoing stake, as a community interest stakeholder within the NC boundaries.
Youth Council Member – Open to Stakeholders between the ages of fourteen (14) and seventeen (17) on the day of the selection. See Admin. Code § 22.814(c). If less than eighteen (18) years of age, the Youth Council Seat member shall be precluded from voting on financial matters, such as neighborhood council expenditures, financial reports, annual budgets, contracts, and recommendations to enter into contracts

Stakeholders, who are elected to hold positions on the North Hollywood Northeast Neighborhood Council governing board will be expected to:

- 1. Attend monthly board meetings
2. Serve on one or more committees
3. Participate in NHNENC outreach events
4. Take the required NC Board Trainings: Code of Conduct, Ethics and Funding.
5. Take actions impacting our community and demonstrate a passion to make a difference in our community.

- Candidates must present documents to the Executive Committee that prove their identity and a "stake" in the Neighborhood Council, as required by each seat.
- Examples: Driver's License, Consular Card or Student ID will prove identity. A Driver's License with a current address will also prove that a person lives within the council boundaries.
- Business seats require a business card with a local address, a Business Tax Registration Certificate, or some other indication that the person works (including volunteer work) or operates a business within the council boundaries.
- Community Interest stakeholders must provide a document that proves a substantial and ongoing interest within the boundaries, which is often evidenced by membership in a local organization. However, Community Interest stakeholders can be appointed to either of the vacant Alternate positions.) Signed letters from responsible parties can also be provided. The Secretary will determine the adequacy of the candidate's documentation.
- No actual documents will be kept and interested stakeholders are only required to show the document for verification.
